Fisheries and Blue Growth District - Cosvap, Partner of “HELIOS” project (co-financed under the ENI CBC MED 2014-2020 Programme) is looking for a BLUE ECONOMY CONSULTANT who will be appointed as part of the Helios project.

General Objective

Project HELIOS project aims to help tackle social exclusion and poverty amongst vulnerable groups (i.e. NEETs and Women of all ages) by identifying the sector with greatest potential for growth and job opportunities for these target groups to meet those sector needs through training activities and cross-border traineeships in companies.

Specific objective

The project aims to increase employability in young people belonging to NEETs (up to 30 years old) and Women (all ages) by providing these target groups with marketable skills to prepare them for skill-based occupations, piloted within the Blue & Circular Economy.

Activities

HELIOS partners believe that the “NEET phenomenon” can be tackled and reduced through the implementation of concrete actions, such as data collection, training, coaching, tutoring and sharing of best practices between partners in two of the most relevant sectors of the Euro Mediterranean economy (i.e. Blue and Circular economy) which can generate hundreds of thousands of jobs for young people and women in Mediterranean countries.



1. TASKS/RESPONSIBILITIES/DUTIES AS REQUIRED BY WP2 – Communication

Responsibilities of the selected person will include assisting the Project Communication Manager to:

1. Participation in Identification of target sub-groups from amongst the most vulnerable categories, in own partner country. Report on NEETs and target sub-groups in own partner area as a result of profiling.
2. Participation in Economic sector profiling (Blue and circular economy): the needs analysis and identifying priorities in BaCE.
3. Support for Activity title Mentor Mapping (stakeholder analysis)
4. Participation to Initiatives to better connect TVETs with market needs
5. Assist the development of new curricula to be used in training course programs in collaboration with the beneficiary Lead and the other partners involved
6. Assist the organization of Course Blue and Circular Economy training Courses and Cross-border traineeships
7. Assist branding and marketing campaigns
8. Participation to Impact assessment – monitoring effects on NEETs and skills gained through project actions
9. Participation to developing e-tools for neET awareness, engagement and monitoring. Identifying the best ways to reach and engage NEETs (peer-to-peer NETs) and e-social tool development

2. REQUIREMENTS

1. Graduate in scientific field, enrolled in own professional order from at least 15 years
2. A minimum of 10 years of experience in integrated sustainable development programmes
3. A minimum of 15 years of experience in public and private activities related to the blue economy and the marine environment
4. Language requirement: proficiency in Italian and English and translation skills in the language pair Italian-English (B1 level).
5. Good knowledge of the main work area of the partner (Sicilia, Mazara del Vallo) and its social and enterprise network
6. Strong communication, presentation and organisational skills
7. IT skills: good knowledge of main Office Suite software
