Fisheries and Blue Growth District - COSVAP is partner of the EU Funding project **"HELIOS – enHancing thE social Inclusion Of neetS"**.

The project total budget is € 2.791.437,46€ and it is financed for an amount of € 2.512.293,72 (90%) by the European Union (ENI CBC MED 2014-2020 Programme) through the European Neighborhood and Partnership Instrument.

HELIOS project aims to help tackle social exclusion and poverty amongst vulnerable groups by identifying the sector with greatest potential for growth and by providing marketable skills to NEETs to meet those sector needs through training activities and cross-border traineeships in companies.

Fisheries and Blue Growth District – COSVAP is partner of the consortium composed by the following partners: ARCES Association (Italy), Action Against Hunger (Spain), Institute of Entrepreneurship Development (Greece), Tunisian Union of Agriculture and Fishery (Tunisia), University College of Applied Sciences Planning and External Relations Affairs (Palestine) and The National Center for Agricultural Research and Extension (Jordan).

The HELIOS partners believe that the "NEET phenomenon" can be tackled and reduced through the implementation of concrete actions, such as training, coaching, tutoring and sharing of best practices between partners in two of the most relevant sectors of the Euro Mediterranean economy (i.e. Blue and Circular economy) which can generate hundreds of thousands of jobs for young people and women in the Mediterranean countries.

The project implementation period is 36 months (starting date 01st September 2019).



1. SCOPE

This call is addressed to: economic operators, below candidates, which in reference to WP6 of the HELIOS Project must provide to the District of Fisheries and Blue Growth - COSVAP, hereinafter referred to as COSVAP, the following services described and with the procedures established in the Contract between the District of Fishing and Blue Growth - COSVAP and the Eligible Candidate.

2. REQUESTED SERVICES

Candidates will carry out their activities independently and independently, in compliance with the instructions given by COSVAP following schedules and itineraries provided by COSVAP. The tasks of the candidate suitable for the implementation of WP 6 - O 6.1 are described below.

The tasks of the candidate nominated by COSVAP are described below.

- Services for Social inclusion, using Art through graffiti to improve the perception of NEETs in the eyes of the local community.

The candidate will have to activate collaborations with civil society organizations, volunteer centers or local artists, for the involvement of Neets in the design and construction of an artistic wall on the theme of the Blue & Circular Economy that once built will be an attractive artistic pole so as to help enhance the place aimed at Fishing and Tourism.

The site in which the candidate will have to realize the artistic work will be indicated by COSVAP and will be strategic for the candidate to make a preliminary survey of the site

Quality of service

The candidate will take care of the support to the authorization process for the realization of the graffiti and will verify the places and locations, will evaluate the feasibility and the presence of existing plants (electricity, internet, other).

In any case, it is necessary to carry out on-the-spot checks preferably a few days before the event in order to prepare the necessary technological equipment for the performance of the service.



Also in order to verify the correct delivery methods, to guarantee COSVAP the outputs of the project, for the evidence of services, works, equipment, goods, adequacy of facilities and services provided, the Candidate will provide COSVAP with photos and images of the locations, the places, installations and equipment used during the events.

3. REQUIREMENTS

The task may not be entrusted to candidates who:

a) have been subjected to the preventive measures ordered by the judicial authority provided for by Legislative Decree no. 159 of 6 September 2011 and subsequent amendments, without prejudice to the rehabilitation effects.

b) be legally or temporarily disqualified from the management offices of legal persons and companies or permanently disqualified from public office or for a period of more than three years, without prejudice to the effects of rehabilitation.

c) have been sentenced, by irrevocable judgment, without prejudice to the effects of rehabilitation, or by irrevocable judgment applying the penalty referred to in Article 444, paragraph 2, of the Code of Criminal Procedure, without prejudice to the effects of rehabilitation:

1. on pain of imprisonment for one of the offences provided for by the rules governing insurance, banking and financial activities and the rules governing payment instruments.

2. imprisonment for not less than one year for a crime against the public administration, against the administration of justice, against public faith, against property, against public order, against the public economy, industry and commerce or for a tax offense.

3. imprisonment for one of the crimes provided for in Title XI Book V of the Civil Code and in Royal Decree No. 267 of 16 March 1942.

4. no less than two years' imprisonment for any other wrongful act d) were declared bankrupt, subject to the cessation of the effects of bankruptcy under Royal Decree No. 267 of 16 March 1942, or held the office of President, Administrator by proxy, the Director-General, the Mayor of companies or entities which have been subject to insolvency proceedings, prior arrangement or compulsory administrative winding-up, for at least three years prior to the adoption of the relevant measures, the period of limitation shall be up to five years from the adoption of such measures.

Also, will be considered causes of exclusion those established by art. 80 of L. 50/2016 and L. 21/2021.



4. KNOWLEDGE OF THE LANGUAGE OF THE PROGRAMME

In view of the fact that English is the working language of the ENI CBC MED Programme and therefore of the HELIOS project, the Candidate must guarantee knowledge of the English language.

5. DURATION AND ASSIGNMENT

The assignment has the necessary duration to the development, to rule of art, of the services demanded (art.2) from the notice. The total amount, including taxes, VAT, social security charges, etc. is equal to Euro 6,000.00 (Six thousand).

6. SUBMISSION OF APPLICATIONS AND SELECTION PROCEDURES

The application form, containing the economic offer, must be drawn up according to Annex A, which must be dated and signed by the candidate (original signatures are allowed, scanned and/or digital);

The application shall be accompanied by:

- Europass professional curriculum or company profile, proving previous experience of the candidate duly signed for evaluation, the document must be in the form of a self-declaration (DPR 445/2000).
- No. 2 graphic sketches of different subjects, in pdf format (Max 3mb) or A4, of the wall work to be realized, which will be evaluated beforehand by COSVAP commission.
- Copy of a valid identity document.
- Self-declaration stating the requirements of point 3 of the Notice (DPR 445/2000).

Evaluation criteria.

Applications received by COSVAP in the manner and within the time limits set out in this notice for the award of the assignment will be deemed admissible; all applications that violate these times and methods will be deemed inadmissible. Also for the assignment in question, preference will be given to applications received by candidates who, at the date of submission of the application, have proven experience in the services requested and knowledge of the topics of the base and the territory in which the event will be carried out from the annexes a), c). Only candidates with the most suitable profile and with the required qualifications will be invited to a selective interview by COSVAP.
